ANHA Board of Directors Visit Mississippi Gulf Coast National Heritage Area

From October 9th to 12th, the Alliance of National Heritage Areas (ANHA) held its annual Fall Board Meeting in Biloxi, MS. The event, hosted by the Mississippi Gulf Coast National Heritage Area (MGCNHA) began on October 9th, with a Heritage Development Institute workshop entitled, "Where the Stories Matter Most: Story Based Preservation in America's Gulf Coast." The one-day training explored how heritage professionals working in distressed landscapes can still successfully

engage their communities and visitors.

Focusing on best practices

drawn largely from the experiences of the MGCNHA, workshop sessions highlighted themes such as the impact of environmental change on cultural tradition, the discovery of new voices and audiences through the restoration of distressed landscapes and the role that heritage, culture, and traditions play in the disaster recovery process. Following the workshop, ANHA members were treated to a one of a kind meal at Aunt Jenny's of Ocean Springs. Listed on the National Register of Historic Places, Aunt Jenny's menu features traditional gulf coast cooking, including catfish and shrimp. Situated at the mouth of Biloxi Bay, the evocative 1852 structure sits under 500 year old oak trees, which once appealed to Elvis Presley, a native Mississippian who frequented the restaurant.

On October 10th, ANHA members took part in a fascinating all-day tour of the MGCNHA. Highlights included a meeting with Biloxi Mayor A.J. Holloway at City Hall; a stop at Keesler Air Force Base, a tour of the historic Saenger Theatre, a 1929 vaudeville house rehabilitated into a region-wide performing arts center; a stop at a recently discovered 1701 cemetery site dubbed the "Jamestown of the south" by leading archaeologists; and tours of the historic towns of Ocean Springs and Pass Christian.

On Thursday and Friday, the ANHA Board held its business meetings, with both general sessions as well as more specialized meetings geared towards the concerns of specific board committees. Board Members also heard an update on international partnerships between the ANHA and heritage-development oriented organizations in other countries.

Legislative Update

On September 17, the Senate Committee on Energy and Natural Resources reported on **S. 278, the National Heritage Areas Partnership Act** (Thomas R-WY). The bill is now ready for Senate Floor action.

On September 26, the House Natural Resources Committee held a full committee markup hearing on **H.R. 1483** (Regula R-OH), to amend the Omnibus Parks and Public Lands Management Act of 1996 to extend the authorization for certain national heritage areas and for other purposes. The Bill was ordered to be reported (Amended) by the Yeas and Nays: 23-12.

On September 27, the Senate Energy and Natural Resources

Subcommitee on National Parks held a hearing on **S. 128** (Allard R-CO), to amend the Cache La Poudre River Corridor Act to designate a new management entity, make certain technical and conforming amendments and enhance private property protections and **S. 697** (Specter R-PA), to establish the Steel Industry National Historic Site in the State of Pennsylvania.


On October 10, Rep. Paul Kanjorski (D-PA) introduced **H.R. 3809**: To amend the Delaware and Lehigh National Heritage Corridor Act of 1988 regarding the local coordinating entity of the Delaware and Lehigh National Heritage Corridor, and for other purposes. The Bill was referred to the House Committee on Natural Resources.



National Park Service Launches New Discover Our Shared Heritage Travel Itinerary for Augusta, Georgia

The National Park Service recently launched a new on-line travel itinerary for Augusta, Georgia, the 45th in its ongoing Discover Our Shared Heritage Travel Itinerary Series. The National Park Service's Heritage Education Services, Historic Augusta, Inc and the Augusta Canal National Heritage Area produced the itinerary in partnership with the National Conference of State Historic Preservation Officers and the Georgia Department of Natural Resources. A Tourism Grant from the City of Augusta and the Augusta Convention and Visitors Bureau provided part of the project funding. The new itinerary explores 39 historic places that bring Augusta's history to life. It includes site descriptions as well as photographs and visitor information. The itinerary is available on the National Park Service website at

www.nps.gov/history/nr/travel/augusta/, and visitors can print it as a guide. The Augusta itinerary is part of the Department of the Interior's strategy to promote public awareness of history and encourage visits to historic places throughout the country.

Crossroads of the American Revolution Association Receives Statewide Award

On Saturday Sept. 29, 2007, Preservation New Jersey held its annual Preservation Gala in Florham Park, NJ. At the Gala Preservation New Jersey honored the Crossroads of the American Revolution Association with the annual Sarah P. Fiske Preservation Award for their longstanding commitment to improving popular understanding of New Jersey's

Revolutionary War heritage, while also promoting open space conservation, historic preservation, community revitalization and heritage tourism. Incorporated in 2002, the Crossroads Association – its founders and present leaders – headed the advocacy effort that resulted in Congressional designation of the Crossroads of the American Revolution National Heritage Area in 2006. The Fiske Award is dedicated to the memory of Sarah Pitney Fiske of Morristown, philanthropist, local historian, member and generous benefactor of Preservation New Jersey. It recognizes groups or individuals whose efforts make a significant impact on preserving historic resources in the state. HonoraryCo-Chairs for the 2007 Preservation Gala, U.S. Representative Rodney P. Frelinghuysen and U.S. Representative Rush Holt, were the Congressional co-sponsors of the Crossroads Heritage Area legislation, which was strongly supported by the entire New Jersey Congressional delegation. New Section of Lackawanna River Heritage Trail Completed

On Monday, September 24th, the Lackawanna Heritage Valley Authority (LHVA) and the Lackawanna County Commissioners hosted a ribbon-cutting ceremony to celebrate the opening of a new section of the Lackawanna River Heritage



Trail in Mayfield Borough and Carbondale Township, Pennsylvania. The one-mile section of trail, known as the Lackawanna Heritage Valley Center Trail, is part of a larger 40 mile project which aims to re-connect local residents to the Lackawanna River and to link the valley's major cultural, recreational, educational, and historic sites. The Trail is funded by the National Park Service, the Pennsylvania Department of Conservation and Natural Resources, and PennDOT.



Upper Housatonic Valley National Heritage Area Hosts Heritage Walks

Over the weekends of September 22 & 23 and October 6 & 7, 2007, the Upper Housatonic Valley National Heritage Area hosted a free series of heritage walks. Led by historians, naturalists, and environmentalists, the walks explored the Housatonic River, the history of the villages and towns

in the Upper Housatonic Valley, the geological, ornithological and horticultural resources of the area, and the splendid autumn foliage. This is the sixth year that the Upper Housatonic Valley national Heritage Area has sponsored the event. The Advisory Council on Historic
Preservation is accepting nominations for the 2008 Preserve America Presidential Awards.
The program recognizes exemplary heritage tourism and historic preservation programs and projects that meet 2008 Preserve America Presidential Award criteria. Beginning this year, preservation projects that are primarily publicly funded are eligible for consideration, unlike past years when preservation projects had to be primarily privately funded.
Nominations must be postmarked no later than **November 1, 2007**. More information and a nomination form are available at www.preserveamerica.gov.

The objective of the Conservation Trust is to support conservation activities around the world as they fit within the mission of the National Geographic Society. The trust will fund projects that contribute significantly to the preservation and sustainable use of the Earth's biological, cultural, and historical resources. 

Silos and Smokestacks Hosts "Teaching with Historic Places"

Silos and Smokestacks National Heritage

Area, in partnership with the Public History Program at the University of Northern Iowa,

Augusta Canal National Heritage Area

The Augusta Canal has been in existence since 1845. One of the first successful industrial canals in the southern states, today the scenic waterway is the only American industrial power canal still in continuous use for its original

purposes. Unlike some other canal-centered heritage areas that cover many square miles along transportation canal corridors, the Augusta Canal is one of the country's smaller National Heritage Areas, encompassing only about a dozen miles of waterway and adjacent

land. Although most of the mighty textile mills along its banks no longer manufacture fabric, three still produce

hydroelectricity as the canal's water surges through turbines on its way back to the Savannah River. In fact, the Augusta Canal NHA earns a significant portion of its operating income from the power generated by the canal.

The Augusta Canal was Georgia's first National Heritage Area, designated 1996. In 2003 the Augusta Canal Interpretive Center at Enterprise

Mill opened and later that year, the first of two replica Petersburg Boats began service for guided canal tours. Improvements to enhance recreation and cultural tourism along the canal include renovation of the Headgate structures and 1875 locks, extension of the New Bartram multi-use trail, completion of recreational amenities including a

canoe/kayak dock, stairway to the Savannah River and Pedestrian Bridge at Savannah Rapids Park.

ACNHA offers a wide variety of experiences to both local residence and visitors. These include:

Petersburg Boat guided canal tours. One-hour, three-hour and specialty narrated tours offered several times each day and for group charter.

Augusta Canal Interpretive Center at Enterprise Mill. 10,000 square-foot interactive museum housed in refurbished 1880's textile mill. Winner of 2005 Georgia Historical Society Award for best Georgia History Exhibit.

Headgate Historic Structures at Savannah Rapids Park- Locks dating from 1845 and 1875, Lockkeepers Cottage housing Columbia County's Regional Visitor Information Center, docks, bridge and outdoor dining buildings. The popular canal towpath begins here.


Towpath and Trails. Multi-use trail system includes the historic towpath, the New Bartram Trail, and links to downtown Riverwalk and Columbia County's trail systems, creating a 40-mile network of pedestrian and bike trails.

Paddling. Local outfitters provide canoe and kayak rentals on the canal. Access to the Savannah River is available at several points.

Future plans call for mixed-use redevelopment along the canal's urban third level, a previously blighted area that has undergone extensive environmental remediation. As funding becomes available, additional segments of multiuse trail will be added to the existing trail system.

The success of the Augusta Canal since its National Heritage Area designation has sparked renewed interest from city leaders and concerned citizens. They see its potential to become a catalyst for economic development in the 21st Century, just as it was in the

19th. Proposals to reroute the canal through Augusta's downtown and to build an urban kayak course are stimulating lively conversations about the future of the waterway.
